AO Open Forum

C-ID continued to work closely with the CCC Technology Center (CCC TC) to address issues which affected the AO submission process. Some of the issues and bugs addressed in the latest release include:

- Fixing submissions to appear correctly in the AO queue
- Adding a “download all submissions” button for AOs
- Improving search filter function
- Fixing the status on submissions that appeared “deactivated” in the AO queue
- Allowing submission of multiple CORs for single descriptor

Along with the recent updates, the C-ID team is aware of existing website bugs and requested enhancements that the CCC TC is actively working to resolve. We welcome your input and suggestions – you can report website bugs on this [spreadsheet](#).

Duplicate COR Submissions

Articulation Officers, please note that in order to create a new submission, the blue “Add and Finalize Submission” button functions as a “Submit” button whereas the “Add Course” button allows the inclusion of multiple CORs. Currently there are a number of submissions in the system with a duplicate COR attached. We ask that you please delete and resubmit any submissions in your queue with two identical CORs. C-ID Discipline Input Group (DIG) Meetings

C-ID held two Discipline Input Group (DIG) meetings to discuss the creation of associate degrees that feed into baccalaureate degree programs offered within the California community college segment. The DIG meetings were held for the following disciplines: Automotive Technology, Biomanufacturing, and Respiratory Care.

As a result of these two meetings, Automotive Technology faculty drafted a model curriculum and identified a potential need for additional descriptors and four certificates. Biomanufacturing faculty drafted a model curriculum and identified a need for more descriptors in the manufacturing segment of industry. Faculty from Respiratory Care drafted a model curriculum but expressed concern over many key differences in courses and programs from school to school, making the creation of C-ID descriptors challenging.

After the successful DIG meetings, the C-ID team is seeking Faculty Discipline Review Group (FDRG) members for Automotive Technology, Biomanufacturing, and Respiratory Care. We are looking for part- or full-time faculty with curriculum experience who are available approximately two to four times per year for conference calls in order to create and finalize draft descriptors and MC.
