### **ADT Submission Reminder**

There has been some confusion surrounding course submissions in light of CCC Chancellor's Office (CCCCO) [memo AA 17-17](#), regarding Associate Degree for Transfer (ADT) submissions. Please note that the CCCCCO allows the inclusion of courses that have been submitted to and are under C-ID review for over 45 days to be included in an ADT submission the CCCCCO. C-ID would like to remind folks that this does not negate the requirement for C-ID approval nor are courses approved after 45 days. Colleges should still continue to pursue their efforts to gain C-ID approval for courses submitted to the C-ID system.

## DISCIPLINE UPDATES

### Addiction Studies

The C-ID Addiction Studies Faculty Discipline Review Group (FDRG) recently finalized one (1) CCC Model Curriculum (MC) and three (3) descriptors: ADS 195X Diverse Populations, ADS 200X Field Work/Internship in Addiction Studies, and ADS 210X Addiction Studies Internship Seminar. ### Child and Adolescent Development

In 2015, the California Commission on Teacher Credential (CTC) revised the Elementary Teacher Education Multiple Subject program standards. As a result of those changes, the C-ID Child & Adolescent Development Faculty Discipline Review Group (FDRG) reviewed C-ID CDEV 100 and recommended including the following content.

- Identify and define various types of abuse and neglect and describe their impact on development.

Statewide vetting recently concluded for the proposed changes, and the Child and Adolescent Development Faculty FDRG will convene to discuss the feedback. We would like to note, that, if approved, these changes will necessitate the re-submission of course outlines to C-ID. Please be on the lookout for updates as C-ID explores potential mechanisms to expedite these re-submissions.
